WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014, on 01.12.2014.

2. AND WHEREAS, the institution i.e. Mangal Ram Woman's College of Education Pukhla Jyeshthi Head Near Railway Crossing Sagar MH State-313601, Bhor has been recognized for B.Ed course by NRC vide order No. F-NRC/NCTR/S-HR-1403-459588 dated 14th May 2008 for an intake of 100 students.

3. AND WHEREAS, the institution has by affidavit committed to cease under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

(ii) The application-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (ECL), Land Use Certificate (LUC) and Building Plan (BP) in the specified formats available on the website to the Regional Committee if proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Institution as part of the application.

(iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committees that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

(iv) In case any existing institution's matter is subjudice under e-court directions/SCN under section 17 of the NCTE Act/Complainant etc., the institution shall be required to submit a copy of the Heir's Certificate/SCN/complainant already submitted alongside the documents, if any together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit a copy of the SCN under section 17 of the NCTE Act/Regulations, 2014 with a copy of the order/Heir's of the affiliating State Govt, and related other documents as indicated in the revised format/recognised order. The final decision shall be subject to the directions given by the Heir's/His Court in the Writ Petition/Case decided by the Northern Regional Committee in respect of Section 17 Complainant cases etc.

1. **Non-Hospitalized:** In the Name of the Doctor, the Physician, Hospital Superintendent, HPHC or Doctor issues the Non-Hospitalized Certificate or Discharge Report, Statement of Discharge, Physician's Attendant Report, Physician's Statement of Discharge, Physician's Statement of Non-Hospitalization, Physician's Statement of Non-Hospitalization with Non-Discharge or Statement of the non-discharged medical services before 11.00.2015.

2. **Hospitalized:** The Hospital Superintendent or his/her representative is responsible for the preparation of the Discharge Report, Statement of Discharge, Physician's Attendant Report, Physician's Statement of Discharge, Physician's Statement of Non-Hospitalization, Physician's Statement of Non-Hospitalization with Non-Discharge or Statement of the non-discharged medical services before 11.00.2015.

3. **The institution which refers to the Regional Committee in a Self-Assessment Report on the need of care:** The institution which refers to the Regional Committee in a Self-Assessment Report on the need of care, shall provide the following information:

a) The institution shall maintain at its disposal 10 weeks on a per provisions of HPHC Resolutions and annexes displayed below.

b) Generalized procedures along with specific details in the institution.

c) Details of the Doctor, and staff to be appointed as medical certificates along with their names, titles, qualifications, and other relevant details.

d) Details of medical personnel having the required classes along with their qualifications, Percentage of participation in the training, and the date of admissions, if any, date of admissions.

e) Five principal clinical departments.

f) The number of beds available in the institution.

g) The number of beds available in the institution intended to admit additional, if any, in the last quarter.

h) The number of beds available in the institution intended to admit additional, if any, in the next quarter.

i) The number of beds available in the institution intended to admit additional, if any, in the next year.

j) The number of beds available in the institution intended to admit additional, if any, in the next three years.

If the institution concerned may the above conditions on the provision of the MDTA Act, Royal
Commissioner and Board of Trade make and bind them under, the institution will cause itself to be subject to the
Institutional Code of Recognition by the Registered Commissioner under the provisions of Section 10(1) of the
MDTA Act.
